The Sault Tribe Health Division received the Strong Systems Stronger Communities grant in the summer of 2023. They collaborated with the Director of Quality, Risk, and Compliance at MyMichigan Medical Center Sault, Stephanie Pins, to provide a quality improvement (QI) training opportunity to all Sault Tribe Health Division staff. Throughout November of 2023, staff could participate in four trainings on the following topics: Basic Foundations of QI, QI Identifying Priorities and Tools, QI Processes and Competency, and QI Innovation, Success, and Sustainability.

The post-assessment report shows that 100% of staff attendees answered yes to the questions, "Do you feel you have a better understanding of quality improvement work after this training? After this training, do you feel more comfortable using the Plan-Do-Check-Act performance improvement tool? Are you able to identify what key performance indicators (KPIs) are for the area where you work?" Also, 70% answered likely or very likely when asked, "Do you feel you can implement change in the work that you do?"

Staff unable to attend the four training sessions can access the recordings at their convenience. The recordings provide Sault Tribe Health Division team members with ongoing QI training references to assist in their continuous improvement efforts.

Shingrix Vaccination Study with Marquette County Sault Tribe Patients

Did you know the same virus that causes chickenpox can be reactivated years later to cause shingles? Anyone who has had chickenpox may develop shingles, also known as herpes zoster. However, not everyone who has had chickenpox will develop shingles. Vaccination is one way to increase your likelihood of protecting against shingles symptoms, including pain, itching, tingling, fever, headache, chills, upset stomach, and a rash that often develops.

The CDC recommends that adults 50 years and older get two doses of the shingles vaccine (Shingrix). According to the CDC, Shingrix "is more than 90% effective at preventing shingles and long-term nerve pain called postherpetic neuralgia, or PHN."

The Sault Tribe Community Health Department in Marquette, Michigan, completed a quality improvement study to investigate and increase the herpes zoster virus (shingles) vaccination rate among eligible Sault Tribe Indian Health Services patients 50 years and older living in Marquette County. First, staff identified and ran a data report on eligible patients, which indicated 106 of 179 (or 59%) had been appropriately vaccinated for herpes zoster with the Shingrix vaccination before the start of the study. The Government Performance and Results Act (GPRA) target rates for age-appropriate vaccinations in patients over 19 were 55.1% in 2021 and 44.4% in 2022, the 2023 benchmark for the study.

Next, staff contacted patients needing the Shingrix vaccination, and an additional 33 patients were vaccinated, bringing the total to 139 of 179 (or 78%). The remaining 22% or 40 eligible patients either chose not to receive the vaccine or did not respond to telephone messages. The study found that although the original Shingrix vaccination rate for eligible patients, 59%, was already above the GPRA benchmarks of 55.1% and 44.4%, the rate quickly rose to 78%, resulting in more Marquette County Sault Tribe patients protected against shingles and its symptoms. In addition, a corrective action plan, including a chart preparation system, new staff, chart reviews, and immunization clinics, was updated to ensure vaccination reminders are efficiently completed moving forward.
